4. Secondary Mark-sheet / Academic Transcripts.
5. Secondary Admit Card.
6. Caste Certificate (to avail reservation facility) from appropriate authority as per Govt. Rule.
7. PH Certificate (to avail reservation facility) from appropriate authority as per Govt. Rule.

COMMENCEMENT OF 1ST SEMESTER CLASSES: Candidates admitted through MOP-UP Counselling shall attend their respective 1st Semester classes from the date of admission, i.e. **24.09.2026 or 25.09.2026, as applicable.**
